In consideration of one dollar and other good and valuable consideration. We, the Owners of the Stallion, _____, Registry Number, _____, denote, transfer and assign to the **Ontario Quarter Horse Breeders' Futurity Stallion Service Sale**, a breeding service for the year 20____ to the above-named stallion. It is expressly understood by all parties to this agreement that this breeding service is assignable only by the **Ontario Quarter Horse Breeders' Futurity Stallion Service Sale**, pursuant to the rules, terms and conditions of the Annual Stallion Service Sale for the year in which said breeding applies, said terms and conditions being incorporated herein by direct reference thereto. All parties to this agreement are further bound and agree to all of the following terms and conditions.

1. That stallion owner will not be responsible for any disease, accident, sickness and/or death of mare or foal, and similarly mare owner will not be responsible for any disease, accident, sickness and/or death of stallion.
2. Mare, in order to qualify for this breeding service, must be haler broken.
3. Board will be charged to the mare owner by stallion owner at the following rates:

4. a) Stallion owners shall diligently try to settle below mare to the best of their abilities, and shall have absolute discretion to determine the best method to breed each mare, including the right to retain a licensed veterinarian to assist therein. Any veterinarian expenses incurred thereby shall be paid for by mare owners.
